APPOINTMENT OF SPECIAL OFFICERS FOR TOWN PANCHAYATS UNDER THE TAMIL NADU DISTRICT MUNICIPALITIES ACT.

[G.O. (Ms) No. 145, Municipal Administration and Water Supply (Election), 24th October 2016, Aippasi 8, Thunmugi, Thiruvalluvar Aandu-2047.]

# No. II(2)/MAWS/687(c-1)/2016.

WHEREAS the Tamil Nadu State Election Commission has issued a notification for the purpose of filling up of ordinary vacancies in the offices of ward members / councillors of Town Panchayats, Municipalities and Corporations and called upon the electors to elect their respective ward members / councillors in accordance with the programme specified therein;

AND WHEREAS the Hon'ble High Court of Madras in its interim order, dated the 4th October 2016, in W.P.No.33984/2016 has, among others, quashed the Election Notifications issued for the conduct of Local Body Election by the Tamil Nadu State Election Commission and directed to issue fresh notifications, conduct election and complete the election process as per law, at the earliest not later than the 31st December 2016 and to administer the Local Bodies by appointment of Special Officers till the elections are held, as the present terms of the present Local Bodies are to expire soon and the same cannot be extended beyond five years;

AND WHEREAS the Director of Town Panchayats and the Tamil Nadu State Election Commission have requested the Government to appoint Special Officers to administer the Town Panchayats as the terms of councils are due to expire on the 24th October 2016:

AND WHEREAS the Governor of Tamil Nadu has promulgated the Tamil Nadu Municipal Laws (Third Amendment) Ordinance, 2016 (Tamil Nadu Ordinance 2 of 2016), whereby section 375-B was inserted in the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920) enabling the State Government to appoint Special Officers to the Town Panchayats;

AND WHEREAS, in view of the circumstances aforesaid, it is necessary to appoint Special Officers to exercise the powers and to discharge the functions of the Town Panchayats under the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920), until the day on which the first meeting of the councils of the Town Panchayats are held after ordinary elections to the Town Panchayats, after the date of commencement of the said Ordinance or until the 31st day of December 2016, whichever is earlier;

NOW, THEREFORE, in exercise of the powers conferred by section 375-B of the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920), the Governor of Tamil Nadu hereby appoints,-

- (1) the Assistant Directors of Town Panchayats specified in column (3) of Schedule-I below as the Special Officers for the Town Panchayats specified in column (4) thereof; and
- (2) the Executive Officers specified in column (3) of Schedule-II below as the Special Officers for the Town Panchayats specified in column (4) thereof.
  - 2. This Notification shall come into force on the 25th October 2016.
