The Governor of Tamil Nadu having satisfied that the additional lands specified in the Schedule below are acquired under TNRSP-II Highways for the public purpose, to wit for four laning and strengthening of SH-37 Oddanchatram-Dharapuram-Tiruppur Road K.M. 37/400 to K.M.126/200 in Oddanchatram Village in Oddanchatram Taluk, Dindigul District and it having already been decided that the entire amount of compensation to be awarded for the acquisition lands is to be paid out of the funds controlled and managed by the Divisional Officer, TNRSP-II, Tiruppur and after having considered the cause shown by the owner or other persons having interest in

the said lands, as the case may be, do hereby publish the following notice under sub-section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34 of 2002).

Under sub-section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34 of 2002), the Governor of Tamil Nadu hereby acquires the additional dry lands specified in the Schedule below and measuring an extent of 1308 Square metres for four laning and strengthening of the State Highways (SH-37) Oddanchatram-Dharapuram-Tiruppur Road K.M. 37/400 to K.M.126/200.
