No. II(2)/HO/59/2016.—The members of the Police Force of the ranks of Police Constables, Police Constables Grade-I, Head Constables and Woman Head Constables of the local Police and Havildars of Armed Police, totaling 1500 including those working in the Directorate of Vigilance and Anti-Corruption, whose names are listed in the Annexure, have been awarded the Tamil Nadu Chief Minister's Constabulary Medal on the occasion of Pongal, 2016.

2. They are eligible to draw monthly allowance of Rs.200/- (Rupees Two Hundred only) per month, as specified in rule 10 of the rules governing the award of the Tamil Nadu Chief Minister's Constabulary Medals, issued in the G.O. Ms. No.71, Home (SC) Department, dated 12-1-1982 and subsequently amended upto 18-8-2009 with effect from 1st February, 2016.
