

No.II(2)/HO/321/2016.—In exercise of the powers conferred by clause (1) of Section 20 of the Tamil Nadu Motor Vehicles Taxation Act, 1974 (Tamil Nadu Act 13 of 1974), the Governor of Tamil Nadu hereby makes an exemption in regard to the Life Time Tax payable in respect of the 'Multi Utility Van' bearing Chassis No. MCIE4CHAOGPO34980 and Engine No. D63019265, belonging to the Tamil Nadu State Legal Services Authority, Chennai.

Exemption to the two numbers of Item Nos. FA 101 and FA 405 German made Waste Heat Steam Recovery Steam Generators Supplied by Messrs. Rheinstall, Germany and Messrs. Koervar and Lersch, Krefeld, Germany to Messrs Thirumalai Chemicals Limited Ranipet from the Operation under the Boilers Act.

No.II(2)/PW/327/2016.—Whereas the Government of Tamil Nadu are satisfied that, having regard to the material,

design and construction of Waste Heat Steam Recovery Generators and to the need for the rapid industrialization of the country, it is necessary to do so;

Now, Therefore, in exercise of the powers conferred by sub-section (3) of Section 34 of the Boilers Act, 1923 (Central Act V of 1923), the Governor of Tamil Nadu hereby exempts two numbers of iterm Nos. FA 101 and FA 405 German made Waste Heat Steam Recovery Steam Generators supplied by Messrs. Rheinstall, Germany and Messrs. Koervar and Lersch, Krefeld, Germany to Messrs Thirumalai Chemicals Limited, Ranipet from the operation of the provisions of the said Act to enable erection and registration under the said Act subject to the following conditions, namely:—

a. design and construction of boiler component is in accordance with the international code or standard including British Standards (BS), American Society of Mechanical Engineers (ASME) Boiler and Pressure Vessel Code, Tubular Exchanger Manufacturers Association (TEMA), Technical Requirements Document (TRD), GOST and Japanese Industrial Standards (JIS);

b. Material used in the construction are not specifically prohibited by the said regulations;

c. design, construction and materials of boiler or boiler components have been satisfied by the State Government by necessary tests and examination like Remnant Life Assessment, which shall be carried out by the owner.
