The Tamil Nadu Wetland Authority shall identify and select priority wetlands in the State on scientific and objective based criteria for consideration of Central Wetlands Regulatory Authority (CWRA).

The said Authority is authorised to finalise and approve the management plan of any wetland in Tamil Nadu for the submission to the Central Wetland Regulatory Authority as and when required and also put in place regulatory and monitoring protocols for conservation and Developmental activities in all wetlands in Tamil Nadu.
