In G.O.Ms.No.630, Industries Department, dated: 24.9.1998, administrative sanction was accorded for acquisition of lands to an extent of 334.875 hectares under Land Acquisition Act, 1894 in Paranur, Veerapuram, Thenmelpakkam, Rajakulipettai, Anumanthai, Anjur, Kunnavakkam and Chettipunniyam Villages of Chengalpattu Taluk, Kancheepuram District for setting up of Mahindra Industrial Park and necessary acquisition proceedings were initiated for acquisition of lands.

2. In the representation first read above, the petitioners requested the Government for dropping the land acquisition proceedings against their lands in S.No.405/1B2B Chettipunniyam Village, Chengalpattu Taluk, Kancheepuram District and in the representation second read above, the petitioners requested the Government for dropping the land acquisition proceedings against their lands in S.Nos.405/3, 405/4 and 405/5, Chettipunniyam Village, Chengalpattu Taluk, Kancheepuram District. 4. The Government Order fourth read above was challenged by the Mahindra World City Developers Limited before the High Court of Madras. 5. The submissions of landowners and Mahindra World City Developers Limited (MWCDL) and the records relating to the above matter have been examined carefully and in this regard, the following points are observed:

(i) MWCDL in its claim has requested for inclusion of the 4.88 acres of lands dropped in the G.O.Ms.No.88, Industries Department, dated:30.7.2009 in acquisition for certain requirements like security, administrative office, parking, checking vehicles etc. In this regard, a field inspection was carried out by a senior official of the Industries department to understand and verify the claims of the contesting sides. During the inspection, it was noticed that the flow of vehicles, checking of the same etc. were found to be going on smoothly. The lands dropped from acquisition are being maintained as coconut grove, garden etc without any commercial construction. It was also noted that without these lands, MWCDL has been able to operate their industrial park for the past 12 years. Further, it has been informed that the industrial park of MWCDL has about 1400 acres, which is much above the area for which administrative sanction has been given. In other words, MWCDL is expanding well through acquisition of lands through private negotiation and accordingly, they have enough lands for creating the administrative office, security, parking and other such amenities as may be required by them.

(ii) It is worth mentioning here that the Government has facilitated the project very well by even granting a pathway with a width of 150 feet through forest department land. It is informed that every company inside the MWCDL's Industrial Park is fully protected with compound walls and managed by their own professional security. The Government have already provided adequate and reasonable facilitation and support for acquisition of lands to the project of MWCDL. Further, as already noted, the Company has acquired / purchased additional lands for their industrial park project.

(iii) It is informed that the 4.88 acres of land (for which the Government ordered to drop acquisition *vide* G.O.Ms.No.88, Industries Department, dated:30.7.2009) is a small piece of land on GST Road about 2.5 Kms away from the industrial park of MWCDL.

(iv) The landowners' contention that apart from the entry *via* the main entrance, MWCDL has one more road from Paranur Railway Station to MWCDL, where they have access and parking bay for the entry of trucks is noted.

(v) The landowners have stated that their lands are fully developed thope (orchard) with coconut, mango, sappota, guava, plantain, Red cider and other trees and their farm is equipped with farm produce storage facility, accommodation for farm workers with electricity connection, water connection and complete underground pipe for the entire area for irrigation. These were verified during the field inspection.

(vi) The land owners have further stated that by an order of the Tamil Nadu Government, the acquisition authorities are restrained from acquiring any thope or agricultural land. It is further informed that the Supreme Court Bench in its order dated:20.10.2007 (in SLP (C) No.9954 of 2006 with 4843 of 2007) had categorically upheld the verdict that agricultural lands with average fertility wherein a thope / orchard can be grown cannot be acquired for industrial purpose, in particular for any private industrial purpose.

(vii) During the personal hearing, a discrepancy about the S.No.405/1B2B has been informed by MWCDL. After a field inspection at the disputed lands and based on detailed examination and perusal of copies of various documents and correspondences relating to the above issue, it is clear that the S.No.405/1B2B referred to in G.O.Ms.No.88, Industries Department, dated:30.7.2009 was not the subject matter of Land Acquisition at any point of time and therefore, the dropping of the above Survey Number from Land Acquisition proceedings is considered not correct. As stated by M/s. MWCDL, the same was also confirmed by the Government of Tamil Nadu *vide* its letter No.21191/MIE.2/2006-1, dated:3.11.2006. The Land Acquisition proceedings were initiated only for S.No.405/1B2A and the same were acquired and handed over to M/s. MWCDL. The Company may therefore proceed accordingly and the dropping of S.No.405/1B2B referred to in the G.O.Ms.No.88, Industries Department, dated:30.7.2009 is hereby cancelled.

6. With regard to S.Nos.405/3, 405/4 and 405/5, even though M/s. MWCDL faces some kind of restrictions in the entrance to their industrial park, the lands in question are at least 2.5 Kms away from the Industrial Park area and even at present, the lands are having orchard with fruit and other trees with storage and other facilities like motor pump rooms etc. As rightly mentioned, the individual companies inside the Industrial Park have their own security arrangements and separate security arrangements may not be necessary at the entrance abutting the National Highways since a large number of other dwellings are in between National Highways and main area of the Industrial Park. Similarly, other requirements like administrative office, etc. are available nearer to the Industrial Park and may not be required abutting the National Highways. It is also seen that due to the dropping of the Land Acquisition Proceedings in Survey Nos.405/3, 405/4 and 405/5, the approach to the National Highways has taken a narrow turn which, if it could be avoided, would present a better ambience to the entrance of the Industrial Park from the National Highways. This point, however, is not significant enough to reconsider the decision of Government *vide* G.O.Ms.No.88, Industries, dated: 30.7.2009 as already set out in paras 5(i), 5(ii) and 5(iv). The Company may, however, explore other options to purchase these lands directly from the land owners.

7. Considering all the factors above and detailed examination of the submissions of MWCDL and landowners made in their written statements and based on the field inspection and the perusal of the records relating to the above matter, it is decided that the earlier decision to drop the land acquisition proceedings with regard to S.Nos. 405/3, 405/4 and 405/5 is to be retained and the dropping of the Land Acquisition Proceedings with regard to S.No.405/1B2B is hereby cancelled.
