 - (7) Wherever the existing wages are higher than the minimum wages fixed therein, the same shall be continued to be paid.

- (1) **Dearness Allowance:** In addition to the minimum rates of basic wages fixed above, the employees shall be paid Dearness Allowance as indicated below:-
- (i) The dearness allowance is linked to the Average Consumer Price Index of the Chennai City for the year 2010, that is 161 points (with base 2001 = 100) and for any further raise of every one point over and above 161 points, an increase of Rs.32.00 (Rupees thirty two only) per month shall be paid as Dearness Allowance.
- (ii) The dearness allowance shall be calculated every year on the first April on the basis of the average of the Consumer Price indices of the preceding 12 months, that is from January to December.
- (iii) The first calculation of the dearness allowance shall thus be effective from the date of publication of this Notification in the Tamil Nadu Government Gazette.

- (2) where the same work or work of a similar nature is performed by women, no distinction in the payment of wages shall be made between men and women employees.
- (3) To arrive at daily rates of wages, the monthly wages shall be divided by 26.
- (4) To arrive at monthly rates of wages, the daily rate of wages shall be multiplied by 30.
- (5) Wherever the existing wages are higher than the minimum wages fixed herein, the same shall be continued to be paid.
