#### Order:- No. 779, Home (S.C),16th November 2016.

Based on the proposal dated 04-12-2014 of the Director, Vigilance and Anti-Corruption, Chennai, in the reference second read above and the Director General of Police, Chennai, in letter dated 12-12-2014, in the reference third read above, orders were issued awarding the Tamil Nadu Chief Minister's Constabulary Medal in the Government Order fourth read above to 1500 members of the Police Force of the ranks of Police Constables Grade-I and Head constables of the local Police and Havildars of Armed Police including those working in the Directorate of Vigilance and Anti-Corruption.

- 2. The Director General of Police, Chennai in his letter dated 16.07.2015, fifth read above, has requested to delete the names of some of the Head Constables who were awarded the Tamil Nadu Chief Minister's Constabulary Medal in the Government Order fourth read above, as they were subsequently promoted as Special Sub-Inspector of Police before the issuance of the above said Constabulary Medal.
- 3. The Director General of Police, Tamil Nadu, Chennai, in his letter dated 30.01.2016, fifth read above. has stated that while recommending the name of Thiru G. Ramasamy, Head constable 1230 of Thoothukudi district, there was no mention in the report of the Superintendent of Police, Thoothukudi District, regarding the P.R.No.126/2013 pending against him and later on, has informed the details of the Punishment Roll. The name of Thiru G. Balamuralikrishnan, Head constable 685 was forwarded to Government by the office of the Director General of Police and also by the Director, Vigilance and Anti-corruption. Though Thiru G .Balamuralikrishnan, Head Constable was relieved from Karur District on 26-09-2014, his name was considered for Medal by the Superintendent of Police, Karur was under orders of transfer to Vigilance and and Anti-Corruption.

- 4. The Director General of Police, Chennai in his letter dated 3.2.2016, fifth read above has informed that in its letter dated 16.07.2015, it was inadvertently requested that the name of Sudharsan, Head Constable 2111 (SI.No.1250 of Annexure) may be deleted from the medal awardees list as he was promoted as Special Sub-Inspector. As the charge faced by him could not be proved, further action was dropped against him and hence becomes eligible to receive the medal and his name need not be deleted from the list as proposed earlier.
- 5. The Government, after careful examination of the proposal of the Director General of Police, Chennai, with reference to the rules governing the award of the Tamil Nadu Chief Minister's Constabulary Medal first read above, have decided to accept the proposal and to delete the names of the following ten Head Constables:—
