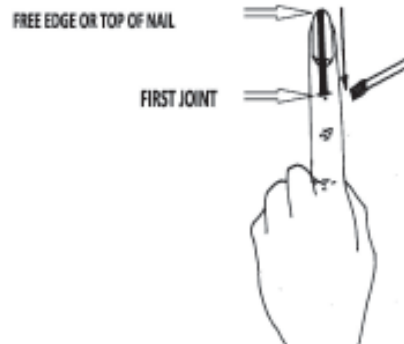

In pursuance of sub-rule (1) (b) of rule 47 of the Tamil Nadu Panchayats (Elections) Rules, 1995 and sub-rule (1) (b) of rule 67 of the Tamil Nadu Town Panchayats, Third Grade Municipalities, Municipalities and Corporations (Elections) Rules, 2006 and in supersession of the Notification No.VI(2)/457(f-1)/2011, Published at Part VI – Section 2 of the *Tamil Nadu Government Gazette* Extraordinary, No.340, dated September 16, 2011, at page number 1, the Tamil Nadu State Election Commission hereby directs that before delivering the ballot paper or ballot papers to the elector, or before allowing to record his/her vote in EVM, indelible ink should be applied as a line from the top end of the nail to the bottom of the first joint of the left forefinger as shown in the diagram below:–
