**No. 33/2016.**—In exercise of the powers conferred under Section 13 of the Code of Criminal Procedure 1973 (Central Act 2 of 1974), the High Court hereby appoints Tmt. L. Maithily, Probationary Deputy Collector by direct recruitment, for the year 2011-2013, **for a period of 180 days, on part time basis**, to be the Special Judicial Magistrate in Kancheepuram District, from the date of assumption of office. The powers may be withdrawn as and when she completes her training in Kancheepuram District and confers upon her the ordinary powers conferrable under this Code on a Magistrate, to try such cases, which were earlier tried and dealt with by an erstwhile Judicial Second Class Magistrate, for completing her Magisterial Training in Kancheepuram District.
