(a) The Elections will be held in accordance with rules and procedures stipulated for the conduct of Election to the University authorities in the Act and Statutes of this University.

(b) Nominations should be made in the prescribed form which may be obtained from the Returning Officer.

Nomination papers shall be enclosed in an envelope superscribing the above elections (each election separately) and sent by Registered Post (Acknowledgment due), so as to be received by the Returning Officer/Registrar, Manonmaniam Sundaranar University, Abishekapatti, Tirunelveli, within the date and hour fixed or delivered either in person or by messenger to the Returning Officer within the last date and hour fixed. Nomination papers that are not enclosed in an envelope, superscribed and sent by Registered Post or are not delivered in person or by messenger as required above shall be declared invalid.

(c) An elector shall be eligible to subscribe either as proposer or as seconder in nomination papers, only as many times as there are vacancies but not more.
