In exercise of the powers conferred by sub-section (4) of Section 32 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972) and in exercise of powers conferred by the G.O. Ms. No. 94, Housing and Urban Development UD4 (1) Department, dated 12-06-2009 which has been published in the *Tamil Nadu Government Gazette* No. 27, Part II—Section 2, Page 228, dated 15-07-2009, the following variations are made to the Master Plan for the Coimbatore Local Planning Area approved under the said Act and Published in the Housing and Urban Development Department Notification No.II(2)/Housing/4377/94 at page 1078 of Part II—Section 2 of the *Tamil Nadu Government Gazette*, dated the 9th November 1994.

VARIATIONS

In the said Master Plan in the “LAND USE SCHEDULE” under the heading “COIMBATORE LOCAL PLANNING AREA” under the sub-heading (b) Non-Notified Detailed Development Plan Area, Chettipalayam Village.

(i) Against the entry, “**AGRICULTURAL (AG-35)**” for the expression,” 510 to 528 (except 521/1), 538 to 543 (except 542, 543), 546 to 552 (except 546, 547, 548, 549/1B, 549/2pt, 3, 550/2), 576 to 591 (except 578/2, 582/5)” shall be substituted.

(ii) Against the entry, “**MIXED RESIDENTIAL (MR.16)**” the expression 521/1 shall be added before the entry “531pt” and 542, 543, 546, 547, 548, 549/1B, 549/2pt, 549/3, 550/2, 578/2, 582/5 shall be added after the entry 531pt.

Ms. No.419, Housing and Urban Development Department, dated 1st June 1984 Under Section 91 (2) of the Tamil Nadu Town and Country Planning Act, 1971 the Member-Secretary, Chennai Metropolitan Development Authority hereby makes the following variation under sub-section (4) of Section 32 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972) to the Second Master Plan for Chennai Metropolitan Area 2026, approved in G.O.(Ms) No.190, Housing & Urban Development (UD I) Department, dated 02.09.2008 and published as per **G.O. (Ms) No.191, Housing & Urban Development (UD I) Department, dated 02.09.2008**, as Housing and Urban Development Department Notification in No.266, Part II - Section 2 of the *Tamil Nadu Government Gazette*, dated the 2nd September 2008.
