**Conferment of Powers**

*(R.O.C. No. 78490/2016-B6)*

No.VI(1)/364/2016.

**No. 154/2016.**—In exercise of the powers conferred under Section 13 of the Code of Criminal Procedure 1973 (Central Act 2 of 1974), the High Court hereby appoints the following 2 Tahsildars in Perambalur District, 8 Tahsildars in Kancheepuram District, 4 Deputy Tahsildars in Namakkal District and 6 Deputy Tahsildars in Erode District, to undergo Magisterial Training for a period of 120 days, from the date of assumption of charge and confers upon them the ordinary powers conferrable under this Code on a Judicial Magistrate to try such cases which were earlier triable and dealt with by an erstwhile Judicial Second Class Magistrate.
