REVISION OF REGISTRATION FEE PAYABLE IN RESPECT OF INSTRUMENTS OF CONVEYANCE,
EXCHANGE, GIFT AND SETTLEMENT AMONG NON-FAMILY MEMBERS UNDER THE ACT.

Under section 78 of the Registration Act, 1908 (Central Act XVI of 1908), the Governor of Tamil Nadu hereby makes the following amendment to the Table of Fees published with the erstwhile Judicial Department Notification No.177, dated the 30th March, 1909, at pages 316 to 319 of Part I of the *Fort St. George Gazette*, dated the 30th March 1909, as subsequently amended:-

AMENDMENT

In the said Table of Fees, in Article 1, after the proviso to clause (a), the following proviso shall be added, namely:-

“Provided further that notwithstanding anything contained in this Table, in case of deeds of conveyance, exchange, gift and settlement among non-family members, the Registration Fee shall be levied at the rate of Rupees four per Rupees hundred or part thereof on the value or amount on which stamp duty under the Indian Stamp Act, 1899 (Central Act II of 1899) is payable.”.
