#### NOTICE

Under sub-section (1) of Section 3 of the Tamil Nadu Acquisition of land for Industrial Purpose Act, 1997 (Tamil Nadu Act 10 of 1999), the Governor of Tamil Nadu hereby acquires the lands specified in the schedule below and measuring Extent of 12.37.5 Hects (or) 30.57 Acres, to the same, a little more or less needed for Industrial purpose, to wit, for the Chennai Airport Expansion Scheme.
