conferred by clause (c) of sub-section (1) and clause (c) of sub-

section (2) of Section 2 of the Indian Tolls Act, 1851 (Central Act
VIII of 1851), the Governor of Tamil Nadu hereby makes the
following amendment to the Highways Department Notification
No. II(2)HW/241(c-1)/2002, dated the 21st March 2002,
published at pages 1-2 of Part II—Section 2 of the
Tamil Nadu Government Gazette Extraordinary, dated the
21st March 2002, as subsequently amended.

AMENDMENT

In the said Notification, in the Schedule the revised Toll
