The Governor of Tamil Nadu having been satisfied that the lands specified in the Schedule below are acquired for Highways Purpose, to wit for Upgrading Paruvakudi - Kovilpatti-Ettayapuram – Villathikulam - Vembar Road (SH-44) from Km. 22/500 to Km. 38/750 and Km. 41/300 to Km. 56/700 in **Ayyaneri Village, Kovilpatti Taluk, Thoothukudi District** and it having already been decided that the entire amount of compensation to be awarded for the acquisition of lands is to be paid out of the funds controlled and managed by the Divisional Engineer, Highways Department, Thoothukudi and after having considered the cause shown by the owner or other persons having interest in the said lands, as the case may be, do hereby issue and

publish the following notice under sub-section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34 of 2002).

#### NOTICE

Under sub-section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act, 34 of 2002), The Governor of Tamil Nadu hereby acquires the dry lands specified in the Schedule below and measuring to an extent of 528 Sq.mtrs. in **Ayyaneri Village, Kovilpatti Taluk, Thoothukudi District** to the same, a little more or less needed for TNRSP-II Highways Purpose, to wit for upgrading State Highways Paruvakudi-Kovilpatti-Ettayapuram- Villathikulam- Vembar Road (SH-44) from Km. 22/500 to Km. 38/750 and Km. 41/300 to Km. 56/700.

The plan of the lands under acquisition is kept in the Office of the Special District Revenue Officer (Land Acquisition), Tamil Nadu Road Sector Project -II, Tiruchirappalli and the Special Tahsildar (Land Acquisition), Tamil Nadu Road Sector Project-II, Tirunelveli and may be inspected at any time during office hours.
