AMENDMENTS TO NOTIFICATION UNDER THE TAMIL NADU PROHIBITION ACT

[G.O.Ms.No.29, Home, Prohibition and Excise (III), 13th October 2017,

In exercise of the powers conferred by sub-section (1) of Section 18-B of the Tamil Nadu Prohibition Act, 1937 (Tamil Nadu Act X of 1937), the Governor of Tamil Nadu hereby makes the following amendments to the Prohibition and Excise Department Notification No.II(1)/PE/239(d)/81, published at page 2 of Part II-Section 1 of the *Tamil Nadu Government Gazette* Extraordinary, dated the 1st May 1981, as subsequently amended.

AMENDMENTS

In the said Notification, in the TABLE, under the entry "Indian Made Foreign Spirits (brand names of which are specified in the Annexure) other than sacramental wine",-

(1) for the expression "Rs.125.00 (Rupees one hundred and twenty five only) per proof litre" in column (2), against the entry under the heading "(i) **ORDINARY BRANDS**" in column (1), the expression "Rs.140.00 (Rupees one hundred and forty only) per proof litre" shall be substituted;

(2) for the expression "Rs.145.00 (Rupees one hundred and forty five only) per proof litre" in column (2), against the entry under the heading "(ii) **MEDIUM BRANDS**" in column (1), the expression "Rs.155.00 (Rupees one hundred and fifty five only) per proof litre" shall be substituted;

(3) under the heading "(iii) **PREMIUM BRANDS**" in column (1),—

(i) for the expression "Rs.170.00 (Rupees one hundred and seventy only) per proof litre" in column (2), the expression "Rs.180.00 (Rupees one hundred and eighty only) per proof litre" shall be substituted;

(ii) for the expression "Rs. 200.00 (Rupees two hundred only) per proof litre" in column (2), the expression "Rs.210.00 (Rupees two hundred and ten only) per proof litre" shall be substituted.
