The Government of Tamil Nadu having been satisfied that the lands specified in the schedule below have to be acquired for industrial purposes to wit to the formation of Double way Broad – Guage Railway line by changing the existing single way Broad-Guage Railway line from Omalur – Mettur Dam and it having already been decided that the entire amount of compensation to be awarded for the lands is to be paid out of the lands controlled or managed by Southern Railway. The following notice is issued under sub-section (1) of Section 3 of the Tamil Nadu Acquisition of land for Industrial Purposed Act, 1997 (Tamil Nadu Act 10 of 1999).

Under sub-section (1) of Section 3 of the Tamil Nadu Acquisition of Land for Industrial Purposes Act, 1997 (Tamil Nadu Act 10 of 1999), the Government of Tamil Nadu hereby acquires the lands in 37.Thindamangalam Village, Omalur Taluk of Salem District as specified in the Schedule below and measuring 0.59.08 hectare (or) 5908 Sq.M. to the same, a little more or less needed for industrial purposes, to wit, for formation of Double way Broad – Guage Railway line by changing the existing single way Broad-Guage Railway line from Omalur – Mettur Dam.
