### NOTIFICATIONS BY GOVERNMENT

#### HIGHWAYS AND MINOR PORTS DEPARTMENT

LEVY OF TOLLS WIDENING OF MADURAI RING ROAD FROM DOUBLE LANE TO FOUR LANE (BOT-TOLL) CERTAIN PERIOD UNDER THE INDIAN TOLLS ACT.

In exercise of the powers conferred by clause (c) of sub-section (1), read with clause (c) of sub-section (2), of Section 2 of the Indian Tolls Act, 1851 (Central Act VIII of 1851), the Governor of Tamil Nadu hereby levies tolls on motor vehicles for the use of the Madurai Ring Road between Meenakshi Mission Hospital and Kappalur after the completion of the Project of Widening the Ring Road from double lane to four lane by M/s. Sri Balaji Tollways (Madurai) Private Limited on Build, Operate and Transfer basis, at the rates specified in column (3) of Table I below in respect of the motor vehicle specified in column (2) thereof. M/s. Sri Balaji Tollways (Madurai) Private Limited shall collect the tolls as specified in the Table I below at the locations specified in Table (2) below:-

(Note.-The rate of tolls prescribed above is calculated with revised base rate for the year 2019-2020 and Wholesale Price Index (WPI) for the month of December 2016. However the effect of increase/decrease of Wholesale Price Index (WPI) on the specified date shall be incorporated before the Commercial Operation Date and the actual applicable rate of tolls shall be revised annually with effect from the 1st April of each year by increasing the base rate at three per cent without compounding in addition to increase/decrease of Wholesale Price Index (WPI) for the month of December of the immediately preceding year in which such revision is undertaken.)

Tolls shall be levied at the following locations:-

(Note.- For the amount to be collected at the toll locations, the rate per km specified in the Table-I shall be multiplied by the effective length and rounded off to the nearest Five Rupees.)

## NOTIFICATION-II

In exercise of the powers conferred by clause (b) of Section 4 of the Indian Tolls Act, 1851(Central Act VIII of 1851), the Governor of Tamil Nadu hereby specifies that no tolls shall be paid by the following classes of motor vehicles, for the use of Madurai Ring Road between Meenakshi Mission Hospital and Kappalur after the completion of the project of widening the Ring Road from double lane to four lane by M/s. Sri Balaji Tollways (Madurai) Private Limited on Build, Operate and Transfer basis:-

**(a) Motor Vehicles transporting and accompanying :**

- (i) the President of India;
- (ii) the Vice-President of India;
- (iii) the Prime-Minister of India;
- (iv) the Chief Justice of India;
- (v) the Governor;
- (vi) the Speaker of the House of People;
- (vii) the Cabinet Minister of the Union;
- (viii) the Chief Minister of the State;
- (ix) the Judge of Supreme Court;
- (x) the Minister of State of the Union;
- (xi) the Lieutenant Governor of a Union Territory;
- (xii) the Chief of Staff holding the rank of full General or equivalent rank;
- (xiii) Chairman of the Legislative Council of State;

- (xiv) the Speaker of the Legislative Assembly of a State;
  - (xv) the Chief Justice of High Court;
  - (xvi) the Judge of High Court;
  - (xvii) the Member of Parliament;
  - (xviii) the Army Commander or Vice-Chief of Army staff and equivalent in other services;
  - (xix) the Chief Secretary to a State Government within concerned State;
  - (xx) the Secretary to the Government of India;
  - (xxi) the Secretary, Council of States;
  - (xxii) the Secretary, House of People;
  - (xxiii) the Foreign dignitary on State Visit;
  - (xxiv) The Member of Legislative Assembly of a State and the Member of Legislative Council of a State within their respective state, if he or she produces his or her identity card issued by the concerned Legislature of the State;
  - (xxv) The awardees of Param Vir Chakra, Ashok Chakra, Maha Vir Chakra, Kirti Chakra, Vir Chakra and Shaurya Chakra, if such awardees produces his or her photo identity card duly authenticated by the appropriate or competent authority for such award;
- (b) Motor Vehicles used for official purposes by.**
- (i) the Minister of Defence including those which are eligible for exemption in accordance with the provisions of the Indian Toll (Army and Air Force) Act, 1901 and rules made there under, as extended to Navy also;
  - (ii) the Central and State armed forces in uniform including para military forces and police;
  - (iii) an executive Magistrate;
  - (iv) a fire-fighting department or organisation;
  - (v) the Tamil Nadu Road Infrastructure Development Corporation/State Government Vehicles used for inspection, survey, construction or operation and maintenance thereof ;
- (c) Motor Vehicles used as ambulance; and**
- (d) Motor Vehicles used as Funeral Vehicle.**
