No.II(2)/HOU/186/2017.—In exercise of the powers conferred by clause (b) of sub-section (1) of Section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu hereby declares his intention to include certain additional areas in the Namakkal Local Planning Area and to make the following amendment to the Housing and Urban Development Department Notification No.II(2)/HOU/1125/99, published at page 470 - 471 of Part II—Section 2 of the *Tamil Nadu Government Gazette*, dated the 22nd September 1999.
