Anjuvannam Peer Mohammadia Muslim Association, Thuckalay Village, Kalkulam Taluk, Kanyakumari District Taking over of the direct Management by the Tamil Nadu Waqf Board Appeal rejected under the Waqf Act 1995.

No.II(2)/BCMBCM/W/839/2017.—Thiru H. Mohammed Hyder Ali had preferred an appeal petition under sub-section (2) of Section 65 of the Waqf Act, 1995 (Central Act 43 of 1995) against taking over the direct management of Anjuvannam Peer Mohammadia Muslim Association, Thuckalay Village, Kalkulam Taluk, Kanyakumari District by the Tamil Nadu Waqf Board in its resolution in item No.151/15 in Rc. No. 144/11/ஆ1/க.குமரி, dated 18-08-2015. The Committee of Anjuvannam Peer Mohammadia Muslim Association, Kanyakumari District with the Muthawali Thiru. H. Mohammed Hyder Ali was elected for three years tenure period from 22-06-2014 to 21-06-2017. Based on certain complaints and after conducting enquiry, the Tamil Nadu Waqf Board assumed the direct management of Anjuvannam Peer Mohammadia Muslim Association, Kanyakumari District.

2. On careful consideration of the contentions raised in the aforesaid appeal and the submissions made by the appellant during the personal hearing, it is found that the Tamil Nadu Waqf Board had given sufficient opportunity of being heard to the petitioner and the petitioner had utilized those opportunities and submitted his arguments before the Board and that the Board did not act against the principles of natural justice. Accordingly, the Government have come to the conclusion that there is no incorrectness or illegality in the order passed by the Tamil Nadu Waqf Board *vide* its resolution in item No.151/15 in Rc. No. 144/11/ஆ1/க.குமரி, dated 18-08-2015. Hence, the appeal preferred by Thiru. H. Mohammed Hyder Ali under sub-section (2) of Section 65 of the Waqf Act 1995 is devoid of merits and the same is hereby rejected.

3. Further, in as much as the three years tenure period of the President and the Committee of the Anjuvannam Peer Mohammadia Muslim Association, Kanyakumari District has expired on 21-06-2017, the Chief Executive Officer, Tamil Nadu Waqf Board is directed to conduct the election for the management of the Anjuvannam Peer Mohammadia Muslim Association, Kanyakumari District, as per procedure.
