Explanations.- (1) Classification of Zones: The Classification of Zones shall be as follows:-

Zone A,B, and C shall comprise of the following Areas:-

Zone A : All Municipal Corporations.
 Zone B : All Grades of Municipalities.
 Zone C : Town Panchayats, Panchayats and other areas.

- (2) **Dearness allowance:** In addition to the minimum rates of basic wages fixed above the employess shall be paid dearness allowance as indicated below:-
 - (i) The dearness allowance is linked to the Average Chennai City Consumer Price Index Number for the year 2010, that is 161 points with base 2001=100 and for every raise of one point over and above 161 points an increase of Rs. 32.65 (Rupees thirty two and paise sixty five only) per month shall be paid as dearness allowance.
 - (ii) The dearness allowance shall be calculated every year on the first April on the basis of the average of the indices for the preceding twelve months. namely, from January to December
 - (iii) The first calculation shall be effective from the date of publication of the Notification in the *Tamil Nadu Government Gazette* based on the Average Chennai City Consumer Price Index Number for the previous year.

- (3) Where the nature of work is the same, no distinction in the payment of wages shall be made between men and women employees.
- (4) To arrive at the daily rates of wages, the monthly wages shall be divided by 26.
- (5) Wherever the existing wages are higher than the minimum wages fixed herein, the same shall be continued to be paid.
