Declaration of Oppilan Forest Block in Kadaladi (Previously Mudukulathur) Taluk in Ramanathapuram District as Reserved Forest under the Tamil Nadu Forest Act

[G.O. Ms. No. 145, Environment and Forests (FR.14), 8th December 2016, கார்த்திகை 23, துன்புக்கி, திருவள்ளூர் ஆண்டு-2047.]

No. II(2)/EF/140/2017.—In exercise of the powers conferred by Section 16 of the Tamil Nadu Forest Act 1882 (Tamil Nadu Act V of 1882), the Governor of Tamil Nadu hereby declares the area, the limits of which are specified in the Schedule below as reserved forest with effect on and from 06-09-2017.

THE SCHEDULE

1. Name of the District : Ramanathapuram
2. Name of the Taluk : Kadaladi (Previously Mudukulathur)
3. Number and Name of the Village : 27 Periakulam (Previously 119 Periakulam)
4. Name of the forest block : Oppilan Forest Block
5. Survey Field Number : 582/1A
6. Extent of the forest block : 337.26.5 hectares.

BOUNDARIES

North.—The boundary line starting from the trijunction point of Survey Field Numbers 582/1A, 443 of No.27, Periakulam Village and Survey Field Number 264 of No.12, Mookkaiyur Village, the boundary line runs generally towards north east along the eastern side of Survey Field Number 264 of No.12, Mookkaiyur Village and southern side of Survey Field Number 46, 473, south and eastern side of Survey Field Number 475, south, west and again southern side of Survey Field Number 477, southern side of Survey Field Numbers 478, 480 all of No.27, Periakulam Village and reaches the trijunction point of Survey Field Numbers 480, 229 and 582/1A of No.27, Periakulam Village. Thence the boundary line turn south along the western side of Survey Field Number 229, southern side of Survey Field Number 229 and reaches trijunction point of Survey Field Numbers 229, 581 and 582-11A. Thence the boundary runs towards south, east and north along the west, south and eastern side of Survey Field Number 581 and reaches the trijunction point of Survey Field Numbers 581, 230 and 582/1A, thence the boundary runs towards eastern side along the southern side of Survey Field Numbers 230, 582/2, 231 and 232 of No.27, Periakulam Village and reaches the trijunction point of Survey Field Numbers 232, 312 and 582/1A. Thence the boundary runs towards east along the southern side of Survey Field Numbers 312, 313, 324 and 325 and reaches the trijunction point of Survey Field Numbers 325, 338 and 582/1 A. Thence the boundary runs towards south along the western side

of Survey Field Numbers 338, 339 south and eastern side of Survey Field Number 339 and reaches the trijunction point of Survey Field Numbers 339, 340 and 582/1A. Thence the boundary line runs towards east along the south and eastern side of Survey Field Number 340, southern side of Survey Field Number 341, west, south and eastern side of Survey Field Number 582/1C, southern side of Survey Field Number 342 and reaches the trijunction point of Survey Field Numbers 342, 355 and 582/1A. Thence the boundary runs south along the western side of Survey Field Number 355, north, west and southern side of Survey Field Number 582/1D, west and southern side of Survey Field Numbers 355, 356 and southern side of Survey Field Number 357 and reaches the trijunction point of Survey Field Numbers 357, 376 and 582/1A of No.27, Periakulam Village.

East.—Thence the boundary runs generally towards south along the western side of Survey Field Number 376 and reaches the trijunction point of Survey Field Numbers 582/1A, 376 of No.27, Periakulam Village and Gulf of Mannar.

South.—Thence the boundary runs generally towards west along northern side of Gulf of Mannar and reaches the trijunction point of Survey Field Numbers 458, 582/1A of No.27, Periakulam Village and Gulf of Mannar.

West.—Thence the boundary line runs generally towards north along the eastern side of Survey Field Numbers 458, 450, 446, 445 and turns west along the northern side of Survey Field Numbers 445, 444, 443 of No.27, Periakulam Village and reaches the starting point.

ADMITTED RIGHTS

Right No.1-Mundapuli Ayyanar Kovil

Right is admitted to a temple called as Mundapuli Ayyanar Kovil, which exists in the southern side of Sayalkudi-Valinokkam Highways road within the Forest Block. Right is admitted to the Oppilan Villagers to worship the gods of the temple. At the time of important festivals in the temple either by local Revenue officials or Panchayat Board President of the Village as the case may be, that prior permission must be obtained from the nearby forest officials. The Mundapuli Ayyanar Kovil is allowed to a length of northern side 47.40 meter, eastern side 40.20 meter, southern side 48.20 meter and western side 40.20 meter. Total extent of the temple is 1922 square meter.

Right No.2 - Ayyanar Kovil

Right is admitted to a temple as Ayyanar Kovil, which exists in the southern side of Survey Field Number 477 of

Oppilan Village within the forest block. Right is admitted to the Oppilan Villagers to worship the gods of the temple. At the time of important festivals in the temple either by local Revenue officials or Panchayat Board President of the Village, as the case may be, that prior permission must be obtained from the nearby forest officials.

The Ayyanar kovil is allowed to a length of northern side 30.20 meter, eastern side 30.20meter, southern side 30.20 meter and western side 30.20 meter. Total extent of the temple is 912 square meter.

Right No.3- Burial Ground

Right is admitted to a burial ground exists in the northern side of the road leading to Othapanai Village within the forest block. It is being utilized by the Villagers of Othapanai.

Burial ground is allowed to a length of northern side 40.20 meter, eastern side of 62.0 meter, southern side of 40.20 meter and western side of 62.40 meter. Total extent of the burial ground is 2500 square meter easement right admitted to Othapanai Villagers to use the burial ground.

Right No.4 - Pathway - Melappanai and Gandhi Nagar Village

Right is admitted to a pathway starting from the Melappanai and Gandhi Nagar Village habitation to burial ground in Survey Field Number 582/1D at the width of 5.00 meter running from west to east at the cutting measurement of 86.40 meter of the eastern boundary of Survey Field Number 582/1C and gets out of the forest and reaches the burial ground at the cutting measurement of 8.00 meter of the western boundary of Survey Field Number 582/1D. Right for the pathway leading to the burial ground from the Melappanai and Gandhi Nagar Village habitation has been allowed and admitted.

The pathway is allowed to a length of 80.40 meter and a width of 5.00 meter within the forest block.

Right No.5 - Over Head Tank and Well

Right is admitted to an over head tank and a round well situated within the forest block close to the habitation (Le.,) abutting the southern side of main road which is used by the Othapanai Villagers for drinking water purpose and permission is allowed to undertake maintenance work by the local body and Tamil Nadu Water Supply & Sewerage Board.

The over head tank and well is allowed to a length of northern side 20.20meter, eastern side 15.00 meter, southern side 20.20 meter and western side of 15.00 meter. Total extent of area is 303 square meter.

Right No.6 - Highways Road

Right admitted to public to use the Highways Road starting from the Sayalkudi to Valinokkam Highways road at station No.10 and runs towards south and reaches the cutting measurement of 32.20 meter eastern boundary of Survey Field Number 446 of No.27 Periakulam Village. Permission is allowed to Highways Department and Local body to carryout the maintenance work.

The Highways roads is allowed to a total length of 1374 meter and width of 8.00 meter within the Forest Block.

Right No.7 - Sayalkudi to Valinokkam Highways road

Right is admitted to public to use the Highways Road stating from cutting measurement of 16.00 meter western boundary of Survey Field Number 338 of Village No.27 Periakulam Village and runs towards south west at the cutting measurement of 10.0 meter through the eastern boundary of Survey Field Number 582/2, runs towards west of the cutting measurement of 10.0 meter from the western boundary of Survey Field Number 582/2, runs towards west at the cutting measurement of 24.20 meter through the eastern boundary of Survey Field Number 581. Again road starting from at the cutting measurement of 30.20 meter from western boundary of Survey Field Number 581 runs towards western side and reaches at the cutting measurement of 100.40 meter from the southern boundary of Survey Field Number 229 all of No.27 Periakulam Village.
