- (b) for the entry, "(2) A diploma in Photography awarded by the National Institute of Criminology and Forensic Science, Ministry of Home Affairs, New Delhi or A diploma in Cinematography or Processing Technology awarded by the Film Institute of Technology, Government of Tamil Nadu" in column (3), against the entry "(ii) By direct recruitment, if no suitable candidates are available for appointment by promotion." in column (2) thereof, the following entry shall be substituted, namely:-
 - "(2) Experience for a period of not less than one year in the field of photography or digital photography.";
