AMENDMENTS TO ADHOC RULES RELATING TO GOVERNMENT POLYTECHNIC COLLEGES (MEN AND WOMEN) AND SPECIAL INSTITUTIONS FOR THE POST OF LECTURER (ENGINEERING SUBJECTS) IN TAMIL NADU EDUCATIONAL SERVICE

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the rules issued with the Higher Education Department Notification No. SRO B-159/97, dated the 17th December 1997 at pages 170 to 171 in Part III—Section I(b) of the *Tamil Nadu Government Gazette*, dated the 17th December 1997.

1. The amendments hereby made shall be deemed to have come into force on 25th May 2010.

In the said Adhoc Rules,-

- (1) for rule 3, the following shall be substituted, namely:-
 - "3. Appointment.—Appointment to the post shall be made only by direct recruitment".
- (2) in rule 4, in sub-rule (b),

(i) for the expression "A First Class Bachelor's degree in the branch of Engineering relating to the post concerned", the following expression shall be substituted, namely,-

"A Bachelor's Degree in the appropriate branch of Engineering / Technology / Architecture with not less than sixty percent of marks or equivalent:

Provided that if the candidate has a Master's Degree in the appropriate branch of Engineering / Technology / Architecture, the candidate should possess a first class or equivalent in the appropriate Branch either at Bachelor's or Master's degree level.";

(ii) for the word "Provided" in the second proviso, the words "Provided further" shall be substituted.

(iii) for the words "Provided further" in the third proviso, the words "Provided also" shall be substituted.

- (iv) The last proviso to rule 4(b) shall be omitted;
- (3) in rule 6, sub-rule (b) shall be omitted
- (4) after rule 8, the following shall be added, namely:---

"9. Savings.—Nothing contained in these rules shall adversely affect the persons holding the post on the date of issue of these rules".
