

Draft Amendment to the Tamil Nadu Legal Metrology (Enforcement) Rules, 2011

[G.O. Ms. No. 76, Labour and Employment (M1), 21st April 2017.]

No. SRO A-20/2017.—The Government of Tamil Nadu intend to amend the Tamil Nadu Legal Metrology (Enforcement) Rules, 2011 and accordingly the amendment to the said Tamil Nadu Legal Metrology (Enforcement) Rules, 2011, which is proposed to be made in exercise of the powers conferred by sub-sections (1) and (2) of Section 53 of the Legal Metrology Act, 2009 (Central Act 1 of 2010) in consultation with Government of India, is hereby published as required under sub-section (4) of the said Section 53 of the said Act for the information of Public who are likely to be affected.

Notice is hereby given that the amendment will be taken into consideration on or after the expiry of a period of fifteen days from the date of publication of the Notification in the *Tamil Nadu Government Gazette*. Any objection or suggestion, which may be received from any person with respect thereto before the aforesaid period of fifteen days will be considered by the Government of Tamil Nadu. Objection or Suggestion, if any, should be addressed to the Secretary to Government, Labour and Employment Department, Chennai-600 009 through the Commissioner of Labour, Chennai-600 006 in duplicate.

DRAFT AMENDMENT

In Schedule-I to the Tamil Nadu Legal Metrology Rules, 2011, after Serial No. 26 and the entries relating thereto the following SI. No. and entries shall be added, namely:-

"27. Sand, Gravel, Blue metal, Rough Stone, Granite Weight or Volume.*

* Volume indicates if the Commodity in transaction is sold by cubic measure."
