Chennai Port Trust Employees (Recruitment, Seniority and Promotion) Amendment Regulations, 2016

The following Notification GSR No. 305 (E) dated the 30th March 2017 issued by the Government of India, Ministry of Shipping and published in Part II Section 3 sub-section (i) of the Extraordinary issue of the Gazette of India, dated 30th March 2016 is republished hereunder as required under section 132(2) of the Major Port Trusts Act, 1963 :-

GSR No. 305 (E). – In exercise of the powers conferred by sub-section (1) of Section 124, read with sub-section (1) of 132 of the Major Port Trusts Act, 1963 (38 of 1963), the Central Government hereby approves the Chennai Port Trust Employees (Recruitment, Seniority and Promotion) Amendment Regulations, 2017, made by the Board of Trustees for the Port of Chennai as set out in the Schedule annexed to this Notification.

2. The said Regulations shall come into force on the date of publication of this notification in the Official Gazette.

SCHEDULE

CHENNAI PORT TRUST

Chennai Port Trust Employees (Recruitment, Seniority and Promotion) Amendment Regulations, 2017

In exercise of the powers conferred by Section 28 of the Major Port Trusts Act, 1963 (38 of 1963), the Board of Trustees of the Chennai Port hereby makes the following Regulations further to amend the Chennai Port Trust Employees (Recruitment, Seniority and Promotion) Regulations, 2008, namely:-

1. Short Title and Commencement:-

(i) These Regulations may be called the Chennai Port Trust Employees (Recruitment, Seniority and Promotion) Amendment Regulations, 2017;

(ii) They shall come into force on the date of publication of the approval of the Central Government as required under the provisions of Section 124 and 132 of the Major Port Trusts Act, 1963, in the Gazette of India.

2. In the Chennai Port Trust Employees (Recruitment, Seniority and Promotion) Regulations, 2008, under Regulation 3, below clause (q), the following shall be added as clause (r):

"(r) 'Regular Service' in relation to any grade means the period or periods of service in that grade rendered after selection and appointment thereto under the regulations according to the prescribed procedure for regular appointment to that grade and includes any period or periods:

(i) Taken into account for the purpose of seniority in case of those already in service at the time notification of regulations;

(ii) During which an employee would have held a post in that grade but for being on leave or otherwise not being available for holding such posts."
