Amendments to the Special Rules for Class LV in Tamil Nadu General Service.

[G.O.Ms.No. 51, Highways and Minor Ports (HK1), 11th July 2017, ஆனி 27, ஹேவிளம்பி, திருவள்ளுவர் ஆண்டு–2048] No. SRO B-48/2017.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for Class LV in the Tamil Nadu General Service:—

- (1) amendment (1) hereby made shall be deemed to have come into force on the 18th October 2001.
- (2) amendments (2) (a), (2) (b), (3), (4) (a), 4 (b) and (5) hereby made shall be deemed to have come into force on the 12th October 2010.

AMENDMENTS.

In the said Special Rules, in PART II,-

- (1) the expression "and Rural Works" wherever it occurs, shall be omitted;
- (2) in rule 1, -
- (a) for the expression "Accounts Officer and Financial Adviser to Chief Engineer (Highways)", the expression "Chief Accounts Officer to the Director General/Chief Engineer (Highways)" shall be substituted;
 - (b) for the expression "Deputy Accounts Officer", the expression "Accounts Officer" shall be substituted;
- (3) In rule 2, for the expression "Office of the Chief Engineer (Highways) and Chief Engineer (National Highways)", the expression "Office of the Director General/Chief Engineer (Highways)" shall be substituted;
 - (4) in rule 3, -
- (a) in sub-rule (a), for the expression "Deputy Accounts Officer", the expression "Accounts Officer" shall be substituted;
- (b) in sub-rule (b), for the expression "Office of the Chief Engineer (Highways), or Chief Engineer (National Highways)" the expression "Office of the Director General/Chief Engineer (Highways)" shall be substituted;
- (5) in rule 4, for the expression "Chief Engineer (Highways)", the expression "Director General/Chief Engineer (Highways)" shall be substituted.
