No. SRO B-50/2017.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Highways Engineering Subordinate (Work charged) Service (Section 15B in Volume III of the Tamil Nadu Services Manual).

2. The amendment hereby made shall be deemed to have come into force with effect from 26-08-2010.

No. SRO B-51/2017.—The following Errata are issued to the Information Technology Department Notification No. SRO B-36(a)/2017, published at pages 1-10 of Part III—Section 1(b) of the *Tamil Nadu Government Gazette* Extra Ordinary No.176, dated the 14th June 2017:-

ERRATA

In the said Notification:-

(a) in rule 7, in THE TABLE, in column (3), in item (b) against category "3(a) System Engineer" in column (1) and the corresponding entry "(ii) By Deputation" in column (2), the expression "Rs.15600-39100+GP 5400" shall be read as "Rs.15600-39100+GP 5100"

(b) in rule 7, in THE TABLE, in column (3), in item (a) against category "4(a) Assistant System Engineer" in column (1) and the corresponding entry "(ii) By Deputation" in column (2), the expression and entries thereon shall be read as,-

"(a) Must hold a degree of Bachelor of Engineering (B.E) or Bachelor of Technology (B.Tech) with Computer Science and Engineering or Computer Engineering or Information Technology or Electronics and Communication Engineering or Electrical and Electronics Engineering as main subject from any recognized University; and".

Amendments to the Tamil Nadu Legislative Assembly Secretariat Service Rules.

No. SRO B-52/2017.—In exercise of the powers conferred by clause (3) of Article 187 of the Constitution of India, the Governor of Tamil Nadu, after consultation with the Speaker of the Tamil Nadu Legislative Assembly, hereby makes the following amendment to the Tamil Nadu Legislative Assembly Secretariat Service Rules :-

AMENDMENTS

In the said Rules,-

(1) in APPENDIX II, in "Class II" in column (1), for the entry "(ii) Direct Recruitment" in column (4) against the entries "3. Librarian" in columns (2) and (3) respectively, thereof, the following entries shall be substituted, namely :-

"(ii) Direct recruitment; or

(iii) Recruitment by transfer from any other service,"

(2) in APPENDIX III, in "Class II" in Column (1), for the entries in columns (4) and (5) against the entry "3. Librarian" in columns (2) and (3) respectively, thereof, the following entries shall be substituted, namely:-

"Direct recruitment or recruitment
by transfer from any other
service

Must hold a Bachelor degree
in any subject and a degree
in Library and information Science
of any University recognized by
the University Grants Commission."
