Aadhaar Requirements: For the Beneficiaries under various programmes such as (i) Issue of ID card to the pensioners, (ii) Mustering of pensioner through Digital Life Certificate availing services through Jeevan Pramaan Portal.

- 1. Treasuries and Accounts Department, Government of Tamil Nadu has decided to issue ID Cards to the pensioners as per G.O.Ms.No.87, Finance (Pension) Department, Dated:10-04-2017.
- 2. It has been decided that mustering of the pensioners may also been done through generation of Digital Life Certificate by availing the services through Jeevan Pramaan Portal.
- 3. For availing services of getting pensioners' Identity Card, the pensioners shall use the Aadhaar card as one of the Identity proof. Apart from that the pensioners shall also produce any one of the following Identity proof.
  - 1) Pension Payment Order
  - 2) Voter ID Card
  - 3) Income Tax, PAN Card
  - 4) Family Card
  - 5) Driving License
- 4. The Pensioners shall approach the e-Seva Centre / Common Service Centre and with the proof of Identity as above can avail the services for receiving the pensioners' ID card.
- 5. For Annual Mustering purpose, the pensioners can approach the Pension Pay Office / District Treasury / Sub Treasury concerned or any other offices of the Treasury Department or the e-Seva Centre / Common Service Centre and shall produce Aadhaar card for the generation of Digital Life Certificate by availing the services through the Jeevan Pramaan Portal of Government of India.
- 6. The Pensioners who do not possess Aadhaar No. they can approach any of the Aadhaar Enrollment Centre located in the nearest Taluk Office, Municipal Office, Collectorates, Zonal Offices of Corporation of Chennai or any other Centres.
