In exercise of the powers conferred by sub-rule (2) of rule 6 of the Tamil Nadu Panchayats (Elections) Rules, 1995, the Tamil Nadu State Election Commission hereby appoints the District Collectors concerned excepting the Collector of Chennai as the District Election Officers for their respective Districts. Subject to the superintendence, direction and control of the Tamil Nadu State Election Commission, they shall co-ordinate

and supervise the preparation and publication of electoral rolls of panchayats and the conduct of elections to the offices of members of Village Panchayats, Panchayat Union Councils and the District Panchayats, Presidents and Vice-Presidents of Village Panchayats, Chairpersons and Vice-Chairpersons of Panchayat Union Councils and District Panchayats in their respective Districts. They shall also perform such other functions as are entrusted to them by the Tamil Nadu State Election Commission, from time to time, in connection with the conduct of Elections to Panchayats.
