No. 34/2017.—In exercise of the powers conferred under Section 13 of the Code of Criminal Procedure 1973 (Central Act 2 of 1974), the High Court hereby appoints the following 8 Deputy Tahsildars in Pudukkottai District, 4 Tahsildars in Ariyalur and one Tahsildar Trainee each in Vellore, Erode and Krishnagiri District to undergo Magisterial Training for a period of **120/180** days, as the case may be, from the date of assumption of charge and confers upon them the ordinary powers conferrable under this Code on a Judicial Magistrate to try such cases which were earlier triable and dealt with by an erstwhile Judicial Second Class Magistrate.
