# Direction regarding Scale of rates Levied by the Tamil Nadu Maritime Board

### **Amendment to Notification**

(Letter No. 1381/S1/2012)

No. VI-3(a)/58/2017.

In exercise of the powers conferred by Sections 37, 38 and 39 of Tamil Nadu Maritime Board Act, 1995 (Tamil Nadu Act 4 of 1996) the Tamil Nadu Maritime Board makes the following Amendment to Section XII of the appendix to the Notification No. VI-(3a)/233(a)/2008, published at pages 1-10 in Part VI - Section 3(a) of the *Tamil Nadu Government Gazette* (No. 285), dated 24-09-2008, with the sanction of Government of Tamil Nadu in G.O.Ms.No. 31, Highways and Minor Ports (HM1) Department, dated 21-04-2017, as follows:—

#### **A**MENDMENT

In the said appendix, for Section XII, the following shall be substituted namely:-

### SECTION XII

Licence fee for construction of Jetties, Piers, Quays, Wharves or any other Marine Structure shall be, at the rates specified in the table below:-

#### **T**ABLE

Slab	Project Cost	Annual Licence Fee collectable for Marine structure
(1)	(2)	(3)
I	Less than Rs. 5 Lakhs	2.5% subject to a minimum of Rs. 12,000/-
II	Rs. 5 Lakhs to less than Rs. 25 Lakhs	2% subject to a minimum of Rs. 12,500/-
Ш	Rs. 25 Lakhs to less than Rs. 2 Crores	1% subject to a minimum of Rs. 60,000/-
IV	Rs. 2 Crores to less than Rs. 25 Crores	0.2% subject to a minimum of Rs. 2,50,000/-
V	Rs. 25 Crores and above	Rs. 5.00.000

2. The above rates shall have effect from the date of publication of this notification in the *Tamil Nadu Government Gazette*.
