2. IV Educational use zone, below the Zoning No. E5, a new row shall be introduced in which E5A, 112 Nanjikottai Village and S.F. No. 319/2A, 3A and 320/5, 6, 8, 9, 10, 11 shall be added against the Zoning number, Village number and S.F. Number respectively.
