ORDER:

In the G.O first read above, orders were issued according permission to the "Times Foundation to construct a 50 bedded hospital at Thiruvottriyur in the land transferred by the Thiruvottriyur Municipality. Accordingly, M/s Times Foundation has taken up the work and the work is nearing completion.

2. In the letter third read above, the Authorized Signatory, Times Foundation has requested to take necessary action to provide water supply and 225 KVA of power through Tamil Nadu Electricity Board as per the electrical load calculations and SLD and also to provide a DG of 250 KVA for the hospital with AMF Panel and to undertake its installation including civil work, if any, for its erection at site. The Superintending Engineer, Public Works Department has forwarded estimates for Rs.4.00 lakhs for the provision of the service connections and its accessories such as cable, main switch and charges payable to the Tamilnadu Electricity Board.

3. In the letter fourth read above the Director of Medical and Rural Health Services i/c has requested the Government to issue necessary orders for the sanction of Rs.4.00 lakhs towards service connection to the 50 bedded hospital at Thiruvottriyur.

4. The Government have examined the proposal of the Director of Medical and Rural Health Services i/c and decided to sanction a sum of Rs.3.96 lakhs towards Tamil Nadu Electricity Board service connection to the 50 bedded hospital at Thiruvottriyur by restricting the Petty Supervision charges and contingencies at 2.5% of the estimate excluding the connection charges. Accordingly the Government accord sanction for a sum of Rs.3.96 lakhs (Rupees three lakhs and ninety six thousand only)

towards Tamil Nadu Electricity Board Service Connection to the 50 bedded hospital at Thiruvottriyur built by "Times Foundation" by restricting the Petty Supervision charges and contingencies at 2.5% of the estimate excluding the connection charges.

5. The expenditure sanctioned in Para 4 above shall be debited to the following head of account:-

4210 -Capital Outlay on Medical and Public Health - 01 Urban Health Services - 110 - Hospital and Dispensaries (including Pharmacy) Schemes in the Eleventh Five Year Plan - II State Plan JA - Buildings - 16 Major works. (DFC 4210-01-110-JA-1602).

6. Necessary additional funds of Rs.3.96 lakhs will be provided in Revised Estimate / Final Modified Appropriation for 2010-11. Pending provision of such funds, the Director of Medical and Rural Health Services / Chief Engineer (Buildings) is authorized to incur the expenditure. The Director of Medical and Rural Health Services / Chief Engineer (Buildings) is directed to include the above expenditure while sending proposals for Revised Estimate / Final Modified Appropriation, 2010-11 to the Government in Finance Department without fail.
