Sub: Provident Fund - General Provident Fund
(Tamil Nadu) sanction of Temporary Advance to the Subscribers who was due to retire within a year on superannuation Instruction- Issue of

Ref: From the Accountant General I. Tamil Nadu, Madras letter No.Fds7/156, 165, 168, 183, 224, 231, 254 and 424 dated 16.9.82 and the last one dated 2.12.82.

As per the provisions of the NOTE under rule 15(1) of General Provident Fund (TN) Rules, in the case of subscribers who are due for retirement within a year, the authorities competent to grant advances to them should fix the number of instalments for recovery not exceeding the prescribed limit so as to recover the advances completely prior to four months of the date of retirement on superannuation

2. You are aware that the above provisions are made with a view to avoid the excess payment which will otherwise may bring some difficulties to Accountant -General (Tamil Nadu) while computing the final amount at credit of a subscriber on his retirement on superannuation. The Accountant-General in his letter cited has brought to the notice of the Government that temporary advances as indicated in the Annexure to his letter have been sanctioned to certain subscribers fixing the number of instalments without taking into account the date of superannuation of the subscribers.

3. I am, therefore, directed to request you to follow strictly the procedure laid down in the provisions of the NOTE under Rule 15 (1) of General Provident Fund (Tamil Nadu) Rules while sanctioning temporary advances to the subscribers who are on the verge of retirement on superannuation and also issue necessary instructions in this regard to the subordinate officers who are competent to sanction temporary advances from the General Provident Fund Accounts.
