Substitute the following for the existing provision under Sl.No.7(1) sanction of staff. ~~To~~ sanction the continuance of staff temporarily appointed, upto a period of six months after the initial sanction in respect of posts created in the departments under their administrative control other than the Secretariat Departments. Where the initial sanction has been for a specific period of less than one year and for a specified item of work, the orders of continuance should state specifically the total

quantum of work to be attended to by the staff at the time of original sanction, the quantum of work actually attended to till the end of the original period of sanction, the reasons for the shortfall and the further time required for completing the work.
