ORDER:

According to Rule 43 (a) of Tamil Nadu Travelling Allowance Rules, a Government servant who takes casual leave or avails himself of restricted holidays while on tour is not entitled to draw daily allowance during such leave or holidays. A point was raised whether a Government servant who takes casual leave for half-a-day on tour is entitled to proportionate daily allowance for the other half-a-day during which he will be on official duty. The above point raised was examined in consultation with the Accountant General, Tamil Nadu.

2/- The Government of India have issued a clarification regarding grant of daily allowance to any Government servant who is on casual leave for half-a-day. According to the above clarification where half-a-day's casual leave is availed of, half daily allowance for that calendar day will have to be deducted. The Government have examined whether provision may be made in the State Rules and have decided to make a similar provision in the State Travelling Allowance rules also.

3. The Government direct that where Government servants take casual leave for half a day while on tour and attend to duty on the remaining half-a-day be paid half daily allowance for that calendar day.


