**ORDER:**

In the Government order first read above, the Government have accorded consent under sub section(2) of Section 24 of the Tamilnadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972) to the Karur Local Planning Authority to the publication of a notice of preparation of the modified master plan under section 26 of the Said Act for Karur local planning area. The Director of Town and Country Planning in his letter second read above has forwarded the modified master plan for the Karur local planning area and requested the Government to accord approval to it under section 28 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972).

2. The Government, after careful examination of the proposal of the Director of Town and Country Planning referred to in paragraph 1 above, have decided to approve the modified master plan for the Karur local planning area. Accordingly, under section 28 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972) the Governor of Tamil Nadu hereby approves the modified master plan for the Karur local planning area. The copies of the said master plan for the Karur local planning area, as approved by the Government, are communicated to the Director of Town and Country Planning.

3. The following Notification will be published in the next issue of the Tamil Nadu Government Gazette. The Director of Town and Country Planning is requested
