ORDER:

In the letter 9th read above, Director of Municipal Administration has stated that the Ministry of Housing and Urban Poverty Alleviation have sanctioned 50% of 2nd instalment (25% of ACA) under IHSDP scheme to the 19 ULBs shown below para 3 and in the letter Deputy Director, Government of India, Ministry of Finance, Department of Expenditure Plan Finance – 1, Division letter No: 59(6) /PF-1, /2009 –808, dated: 30.03.2010 and Lr.No. 59 (6)/PF1/2009 – 19, dated: 12.04.2010. has released the total amount of Rs.1646.85lakh (i.e Rs.1438.32 Lakh+208.53 Lakh) as only 50% of the 2nd

Installment (25% of ACA) to the 19 Urban Local Bodies for the year 2009-2010 and 2010-2011.

The Director of Municipal Administration has also requested the Government to sanction and release the Cumulative Central & State share of Rs.1982.56 Lakh (i.e. 1525.52 Lakh +457.04 Lakh) to the above 19 ULBs as 50% of 2nd installment (25% of ACA) for the year 2010-2011 under Integrated Housing and Slum Development Programme (IHSDP) scheme.

5. The Government after careful consideration, accept the proposal of Director of Municipal Administration at para 4 above, Sanction and release the cumulative Central and State shares of Rs. 1982.56 Lakh (i.e. 1525.52 Lakh +457.04 Lakh) (Rupees Nineteen Crore eighty two Lakhs and fifty six thousand only) to the above 19 ULBs as 50% of 2nd installment (25% of ACA) for the year 2010-2011 under Integrated Housing and Slum Development Programme (IHSDP) scheme. The Director of Municipal Administration is also instructed to send necessary proposal for the balance amount on receipt Government of India release. The release for Thirukazukundram, Alampalayam and R. Pudupatty Town Panchayats will be considered separately.


