ORDER

In the Government order 1st read above, orders were issued to implement a new scheme called “Tamil Nadu Urban Road Infrastructure Project (TURIP)” to improve the urban road infrastructure and to maintain the network of roads constructed under the Project. In order to implement the Project, a separate non-lapsable fund named “Tamil Nadu Urban Road Infrastructure Fund (TURIF)” has been created.

2. Based on the proposals received from the Managing Director & Chief Executive Officer, TNUIFSL and the Director of Municipal Administration for constitution of the Tender Award Committee in their letters third and fourth read

above, the Government after detailed examination has decided to issue suitable amendment to the clause 20 of Tamil Nadu Urban Road Infrastructure Project - Procedures & Guidelines laid down in the Annexure to the G.O. first read above, as follows:

AMENDMENT

For clause 20 of Tamil Nadu Urban Road Infrastructure Project - Procedures & Guidelines in the Annexure to the G.O. first read above, the following shall be substituted:

“20. Appointment of Design Supervision Management (DSM) Consultants:

A) The proposal (s) of the appointment of DSM consultant(s) will be placed before the Tender Award Committee, consisting of the following officials:-

i)	Managing Director & Chief Executive Officer, TNUIFSL	- Chairman
ii)	Director of Municipal Administration or his representative	- Member
iii)	Chief Engineer, Directorate of Municipal Administration	- Member
iv)	Chief Engineer, Chennai Corporation (in cases relating to Chennai Corporation)	- Member
v)	Chief Engineer, Highways Department	- Member
vi)	Assistant Vice President (in charge of procurement), TNUIFSL	- Member
vii)	Assistant Vice President (in charge of Project Development/TURIF) TNUIFSL	- Convener
viii)	Corporation Commissioner/ Municipal Commissioner/Executive Officer and City Engineer/ Municipal Engineer concerned (for the Municipality relating to their ULB).	- Member

B) Based on the recommendation of the above Tender Award Committee, the Managing Director & Chief Executive Officer, TNUIFSL will appoint DSM Consultant(s) and release funds from TURIF, based on the review by the Technical Review Committee.

C) A City Road Plan (CRP) will be prepared by DSM Consultant as appointed above, for selected urban local bodies.
