- Sub: Pension - Revision of Pension – Pensionary benefits to those who retired / died in harness after 1.6.2009 – sending proposals – Regarding.



The Deputy Accountant General (Pension) in his letter cited has stated that despite instructions issued in the Government letter cited, pension proposals in respect of those retired / died in harness after 1.6.2009, are continued to be received in pre-revised pay and that these proposals have been admitted to avoid delay in settlement of retirement benefits. He added that revision in these types of cases is being received now in hard copy and that he would be unable to process paper based revision cases. Therefore, in the interest of pensioners, the Accountant General has prescribed the following procedure.

- i) If pension is already admitted in pre revised scale, the Pay Commission Revision will be undertaken only in soft copy irrespective of the date of retirement.
- ii) If pension is not already admitted, proposals to be forwarded only in revised scale in respect of post 2006 retirees.
- iii) If some pension is already admitted, he will not attend to any other revision other than Pay Commission Revision. Pay Commission Revision will also be done only in soft copy as already decided.
- iv) Other revisions would commence only after 1.4.2010.

2) I am to bring the above procedure being adopted by the Accountant General to the notice of all Heads of Departments for strict compliance so as to enable the Accountant General to accomplish revision of pensionary benefits of all the cases.
