

In the reference first cited, Government have introduced Contributory Pension Scheme to Tamil Nadu State Government employees with effect from 01.04.2003. Subsequently the Government have issued further clarifications in the references

second to fourth cited. Now the Commissioner, Government Data Centre has requested clarification regarding the holidays intervening in respect of cases where the Government servant under pensionable establishment on relief reports for duty in another pensionable establishment, under the Government after availing the Public holidays like Saturday, Sunday and other Government holidays.

2. The Government after careful examination directs that in all cases where an employee working under pensionable service on relief joins a new post on a day after the intervening Government / Public holidays, need not be considered as a break, since the intervening period shall automatically be condoned as per rule 25 of Tamil Nadu Pension Rules 1978.
