In the letter read above, the Director of Municipal Administration has stated that, in B.E. 2010-2011, the Government have provided funds towards the grant under 13th Central Finance Commission recommendation as follows:-

The Director of Municipal Administration is also requested to furnish the utilization certificates for the utilization of

the amount sanctioned in para 3 above to the Govt. in M.A.W.S. and Finance Dept., so as to forward the same to Government of India.
