## ORDER

In the Government Order first read above, the Tamil Nadu Water Supply and Drainage Board was permitted to avail of a loan assistance of Rs.10000.00 lakhs from the Tamil Nadu Urban Finance and Infrastructure Development Corporation towards the execution of Urban Water Supply and Drainage Schemes. In the Government Order second read above, the Government have directed that the loan of Rs.10000.00 lakhs availed of by the Tamil Nadu Water Supply and Drainage Board from the Tamil Nadu Urban Finance and Infrastructure Development Corporation for implementation of Urban Water Supply and Drainage Schemes will be on the terms and conditions with which HUDCO line of credit already availed.

2. The Managing Director, Tamil Nadu Water Supply and Drainage Board in his letter fourth read above has stated that out of the above said loan amount, the Tamil Nadu Water Supply and Drainage Board has drawn a loan amount of Rs.5000.00 lakhs from the Tamil Nadu Urban Finance and Infrastructure Development Corporation on 24.3.2003 which carried the rate of interest at 10.50 % per annum upto 31.3.2004 and further it has been reduced to that of 9.50% per annum for the period from 1.4.2004 to 31.12.2004. The loan amount of Rs.3650.00 lakh and Rs.1350.00 lakhs were drawn on 25.7.2003 and 1.1.2004 respectively which carried the rate of interest at 9.75 % per annum upto 31.3.2004 and further the rate of interest has been reduced to 9.50 % per annum with effect from 1.4.2004 to 31.12.2004 . The Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited has further reduced the rate of interest from 9.50 % to 8.75 % per annum with effect from 1.1.2005. The Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited has further reduced the rate of interest from 8.75 % to 8.50 % per annum with effect from 1.7.2005. Out of the loan amount of Rs.10000.00 lakhs, a sum of Rs.40,89,21,856/-has already been repaid to the Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited upto the end of the quarter 30.06.2010. Therefore, the balance amount that remains to be repaid to the Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited as on 01.07.2010 is Rs.59,10,78,144/-

3. The Managing Director, Tamil Nadu Water Supply and Drainage Board has also stated that further, the Tamil Nadu Water Supply and Drainage Board has borrowed a loan assistance of Rs.187,96,000/- on 3.1.2005 under Mega City Programme and Rs.44,34,000/- on 24.10.2005 from the Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited at the rate of interest of 6.00% per annum and 8.25% per annum respectively for the execution of water supply schemes to Naravarikuppam, Madambakkam and Peerankaranai based on the sanction accorded by the Government. The repayment of Principal commenced from the quarter 31.3.2005 onwards for Rs.187.96 lakhs and from 31.12.2005 in respect of Rs. 44.34 lakhs, out of which a sum of Rs.108,80,441/- and Rs.21,60,148/- have been repaid to Tamil Nadu Urban Finance and Infrastructure Development Corporation upto quarter ending 30.06.2010 respectively . The outstanding loan that remains to be repaid to the Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited is Rs.1,01,89,411/- (Rs.79,15,559 + Rs.22,73,852)

4. The Managing Director, Tamil Nadu Water Supply and Drainage Board has further reported that the amounts released by the Government upto the quarter ended 30.06.2010 have been remitted to the Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited in full. The total amount required from the Government towards the repayment of Principal and payment of interest to the Tamil Nadu Urban Finance and Infrastructure Development

Corporation Limited for the quarter ending 30.09.2010 is as follows:-

5. The Managing Director, Tamil Nadu Water Supply and Drainage Board has therefore requested the Government to release a sum of Rs.3,23,88,720/- to Tamil Nadu Water Supply and Drainage Board for making payment to the Tamil Nadu Urban Finance and Infrastructure Development Corporation.

6. The Government after careful examination accord sanction and release of Rs.3,23,88,720/- (Rupees Three crores twenty three lakhs eighty eight thousands seven hundred and twenty only) as loan to the Tamil Nadu Water Supply and Drainage Board towards payment of interest and principal to the Tamil Nadu Urban Finance and Infrastructure Development Corporation as detailed in para 4 above.

7. The expenditure sanctioned in para 6 above, shall be debited to the following Head of account.

"6215 – Loans for Water Supply and Sanitation -01. Water Supply – 190. Loans to Public Sector and other Undertakings – I. Non Plan – AG. Loans to Tamil Nadu Water Supply and Drainage Board for Tamil Nadu Urban Finance and Infrastructure Development Corporation Urban Water Supply – 01. Repayment of Principal and interest to Tamil Nadu Urban Finance and Infrastructure Development Corporation for Urban Water Supply Schemes (DPC 6215-01-190-AG 0103)

8. The amount sanctioned in para 6 above shall not be paid in cash but shall be credited to the head of account "K Deposits and Advances (b) Deposits not bearing interest – 8443.00 Civil Deposits – 800 other Deposits – BC - Deposits of Tamil Nadu Water Supply and Drainage Board (TWAD Board) DPC 8443 00 800 BC 000C Receipts"

9. The Section Officer, Municipal Administration and Water Supply (Bills) Department is authorized to draw and disburse the amount sanctioned in para 6 above through Pay and Accounts Officer (Secretariat), Chennai- 9 by means of Cheque drawn in favour of Personal Deposit Account No. 6184513396 of Managing Director, Tamil Nadu Water Supply and Drainage Board." as per G.O. Rt. No.1251 Finance (W&M II) Department, dated 30.12.2005 and send it to the Managing Director, Tamil Nadu Water Supply and Drainage Board for depositing the same in the above said Personal Deposit account.

10. The Managing Director, Tamil Nadu Water Supply and Drainage Board shall ensure that the claim made by the Tamil Nadu Urban Finance and Infrastructure Development Corporation is in order and there is no excess claim and no over payment made to Tamil Nadu Urban Finance and Infrastructure Development Corporation by the Tamil Nadu Water Supply and Drainage Board.

11. The Director of Municipal Administration is requested to raise necessary Demands against the Local Bodies concerned and inform to the Managing Director, Tamil Nadu Water Supply and Drainage Board and the Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation for necessary action. The Managing Director, Tamil Nadu Water Supply and Drainage Board is requested to surrender the balance amount if no expenditure out of the balance is likely to be incurred before the end of the financial year.

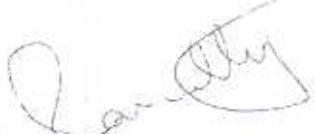
