ORDER:-

Due to adverse seasonal conditions in Dindigul, Villupuram, Virudhunagar and Vellore Districts which are facing drought conditions in some packets, require an immediate financial assistance to combat drinking water scarcity.

2. The Collectors of Dindigul, Villupuram, Virudhunagar and Vellore Districts have sent comprehensive plan to combat drinking water scarcity in Rural and Urban areas. The Collectors of the above districts have stated that deficit rainfall has been recorded in some packets of their districts. They have also stated that in order to tackle the impending water scarcity financial assistance is required **urgently**.
