### ORDER:

In the Government order first read above, the Government have accorded consent under sub-section (2) of section 24 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972) to the Ambur Local Planning Authority for the publication of a notice of preparation of the modified master plan under section 26 of the said Act for Ambur Local Planning Area. The Director of Town and Country Planning, in his letter second read above, has forwarded the modified master plan for the Ambur Local Planning Area and requested the Government to accord approval to it under section 28 of the said Act.

2. The Government, after careful examination of the proposal of the Director of Town and Country Planning, have decided to approve the draft modified master plan for the Ambur Local Planning Area. Accordingly, in exercise of the powers conferred by section 28 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu after consultation with the Director of Town and Country Planning hereby approves the draft modified master plan for the Ambur Local Planning Area. The copies of the modified master plan for the Ambur Local Planning Area as approved by the Government are communicated to the Director of Town and Country Planning.

3. The following Notification will be published in the next issue of the <u>Tamil Nadu Government Gazette</u>. The Director of Town and Country Planning is requested to ensure that the Notification is republished in the manner prescribed in rules 12 and 15 of the Master Plan(Preparation, Publication and Sanction) Rules.

### NOTIFICATION

In exercise of the powers conferred by sub-section (1) of section 30 of the Tamil Nadu Town and Country Planning Act, 1971(Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu hereby publishes the approval of the Government under section 28 of the said Act for the modified master plan for the Ambur Local Planning Area submitted by the Director of Town and Country Planning.

The modified master plan for the Ambur Local Planning Area with all its enclosures shall be kept open to the inspection of the public in the office of the Ambur Municipality during office hours.
