### **ORDER:-**

In the reference read above the Principal Secretary / Commissioner of Revenue Administration has stated that the North East Monsoon 2010 have been very active till 24.11.2010 and the State as a whole received 12% excess rainfall. Some Districts particularly Delta Districts and southern coastal Districts have been battered by very heavy rains during the last few days. Collectors have been reporting that roads have been submerged, and in a few places, stretches of roads have been completely washed away, a few bridges have collapsed and there was extensive damage to irrigation canals and Collectors were in the process of assessing the damage to those infrastructure. The press has been also highlighting the damage to roads and other infrastructure extensively.

2. The Principal Secretary / Commissioner of Revenue Administration has further mentioned that since the actual assessment and the estimation of damage to these infrastructure will cause delay, and suggested to allocate funds to the Departments for temporary restoration of infrastructure affected, which can be sub-allocated by the Secretaries of the concerned Departments to the Districts based on the actual requirements and requested to allot sum of Rs.100.00 Crore to the different departments as follows:

3. The Government after careful examination of the proposal of the Principal Secretary / Commissioner of Revenue Administration accord sanction for a sum of Rs.100.00 Crore (Rupees One Hundred Crore only) for as Calamity Relief Fund for relief assistance for the affected roads and Bridges Canals and other infrastructure.

4. The amount sanctioned in Paragraph 3 above shall be debited the following head of accounts:

5. Necessary funds will be provided in RE/FMA 2010-2011. This item of expenditure shall be brought to the notice of the Legislature by specific inclusion in Final Supplementary Estimates for 2010-2011. Pending provision of such funds in RE/FMA 2010-2011, the Principal Secretary/ Commissioner of Revenue Administration is permitted to draw and disburse the amount sanctioned in paragraph 3 above, as per the existing procedure, to the respective District Collectors and send the utilization certificate to the Accountant General/ Government and also include this item of expenditure shall be included while sending the proposal for RE/FMA 2010-2011 without fail.

6. The Principal Secretary / Commissioner of Revenue Administration may be authorized to allocate the reserve funds for payment of input subsidy to the affected farmers as per Calamity Relief Fund norms, after the assessment is completed by the District Collectors. The District Collectors and Principal Secretary / Commissioner of Revenue Administration are requested to commence the works. [and it should be completed within 45 days.]

7. The Principal Secretary / Commissioner of Revenue Administration shall furnish the details of amount incurred under each head of account mentioned above well in advance so as to include in RE/FMA 2010-2011.

8. The District Collectors concerned shall send a daily report to the Principal Secretary / Commissioner of Revenue Administration in the list of works sanctioned to him department-wise.
