JNNURM – Participation of MPs/MLAs – Formation of District Level Monitoring Committee for JNNURM: UIG & BSUP, UIDSSMT and IHSDP – Orders issued.

### ORDER:

In his letter first read above, the Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited has stated that in the letter No. 14012/101 (18)/10 – NURM-II (Part III), dated 31.3.2010, the Government of India has informed that the National Steering Group of the Mission chaired by Honourable Minister of Urban Development, Government of India deliberated on the issue of participation of MPs/MLAs under JNNURM for monitoring the projects sanctioned under JNNURM and decided that MPs concerned will be associated in monitoring the projects. The Government of India has therefore directed that the State Governments should notify a review and monitoring committee at City/District level which will review and monitor the progress of the projects and reforms.

2. In his letter second read above, the Director of Municipal Administration has stated that, the National Steering Group (NSG) of the Mission

chaired by the Minister of Urban Development, Government of India had deliberated on the issue of participation of MPs/MLAs under Jawaharlal Nehru National Urban Renewal Mission for monitoring the projects sanctioned under Jawaharlal Nehru National Urban Renewal Mission and decided that the MPs concerned will be associated in monitoring the projects. It has been decided that the State Governments should notify a review and Monitoring Committee at city/district level which would review and monitor the progress of projects and reforms.

3. The Director of Municipal Administration has also stated that the composition and functions of the Committee suggested by Government of India for JNNURM I) UIG&BSUP and II) UIDSSMT&IHSDP is as follows.

- i. Concerned MPs/MLAs whose constituency (or part thereof) falls within the Municipal limits – Member
- ii. Concerned Mayor/Chairperson of ULB – Member
- iii. District Collector – Member
- iv. 2 eminent Citizens from CVTC to be nominated by State Government – Member
- v. City Commissioner/CEO of ULB - Member, Secretary

State Government may notify the District Minister/Senior Minister /Senior most MP in the Committee as the chairperson of the Committee.

The Committee would perform the following tasks:

- i. Review Physical and Financial Progress of projects
- ii. Review Progress on Reforms
- iii. Review bottlenecks in implementation of reforms and projects and the way forward.
- iv. Convergence of projects under UIG/UIDSSMT and BSUP/IHSDP as well as convergence of other initiatives at the city/district level with JnNURM

The functioning of the Committee among the other things are,

- i. The Committee should meet quarterly and conduct review of implementation of projects and reforms.

ii. The Committee will submit minutes of the meetings/discussion held and recommendations to the concerned ULBs and SLNAs and State Governments concerned.

iii. The SLNA will ensure that minutes are uploaded on the web and copy is sent to MoUD and MoHUPA. The SLNA will also ensure that action is taken on the recommendations of the committee and action taken on the recommendations of the committee and action taken report is submitted to the State Government and MoUD & MoHUPA. The action taken report must be on the agenda item of all the meetings of the Committee.

4. The Director of Municipal Administration has therefore suggested that the State Government may consider and form a single ' District Level JnNURM Monitoring Committee' in each of the districts (except Chennai) for JNNURM i) UIG&BSUP and ii) UIDSSMT &IHSDP with the following composition:

Hon'ble Cabinet Minister of Government of India hailing from the constituencies in the District. In other cases, the Ministers of Government of Tamilnadu in charge of the district (except Chennai) : Chairman

District Collector : Vice-Chairman

All Concerned MPs/MLAs whose constituency ( or part thereof )falls within the ULB limits : Members

All concerned Mayors /Chairpersons of the ULBs : Members

2 eminent Citizens from City Volunteers Technical Corps (CVTC) ( in the case of Madurai and Coimbatore Corporations) and in other cities, 2 eminent Persons nominated by the Committee from among the panel of 4 names suggested by the Vice-Chairman) : Members

Commissioners of Corporation/ : Member Secretary  
Municipality in the head quarters  
town of the district

5. The Director of Municipal Administration has also suggested that, during the 1<sup>st</sup> meeting, the District Collector may suggest a panel of 4 other eminent persons from CVTC for Coimbatore and Madurai districts/ 4 other eminent persons in respect of other districts to the Committee. The Committee may select two eminent persons from the panel suggested by the District Collector and give approval. Such members shall function for the period of one year and their term may be renewed for a maximum of one more year by the Committee. Subsequently, new members from eminent citizen may be selected by the Committee following the above procedure.

6. The Government after careful examination accept the proposal of the Director of Municipal Administration at paras 4 and 5 above and direct to form a single ' District Level JnNURM Monitoring Committee' in each of the districts (except Chennai) for JNNURM i) UIG&BSUP and ii) UIDSSMT & IHSDP with the following composition.

2 eminent Citizens from City : Members  
Volunteers Technical Corps (CVTC)  
( in the case of Madurai and

Coimbatore Corporations) and in other cities, 2 eminent Persons nominated by the Committee from among the panel of 4 names suggested by the Vice-Chairman)

Commissioners of Corporation/ Municipality : Member Secretary  
In the head quarters town of the district

7. The Government also direct that, during the 1<sup>st</sup> meeting, the District Collector may suggest a panel of 4 other eminent persons from City Volunteers Technical Corps (CVTC) for Coimbatore and Madurai districts/ 4 other eminent persons in respect of other districts to the Committee. The Committee may select two eminent persons from the panel suggested by the District Collector and give approval. Such members shall function for the period of one year and their term may be renewed for a maximum of one more year by the Committee. Subsequently, new members from eminent citizen may be selected by the Committee following the above procedure.
